The Organic Agriculture Produces Market Complex at Sixmile, Khanapara, Guwahati has been established on the initiative of the Department of Agriculture and Assam State Agricultural Marketing Board as a part of our overall strategy to provide a marketing hub to the farmers, traders and consumers of organic agriculture produces.


The ASAMB has taken initiative for the better and efficient operation & maintenance of the Organic Agriculture Produces Market Complex at Sixmile through Public Private Partnership (PPP) route by appointing a Private Partner/Operator through a transparent National Competitive Bidding Process and the selected bidder shall be given the right to run & operate the Market Complex based on the criteria provided in the RFP. The Market Complex shall be used only for local marketing & export of agricultural and allied products particularly organic agricultural produces and not for any other purposes.

The Technical, Financial and other qualification criteria and the process of selection of the partner are given in the RFP document.

The Assam State Agricultural Marketing Board invites proposals from the eligible applicants of National repute having proven track record and experience in marketing of organic and allied agricultural produces. Preference will be given to the parties having experience in operation and maintenance of agriculture produce markets (Mandis) in major scale.
