Assam State Agricultural Marketing Board 2016-2017

Introduction:

To provide for better regulation of buying and selling of agricultural produces and the establishment of markets for agricultural produces in the State of Assam, the Assam Legislative Assembly passed a bill in the year 1972 known as "**The Assam Agricultural Produce Market Act, 1972**" and received assent of the President of India on 3rd September, 1974 and subsequently the Act was enforced in the State with effect from 15th June, 1977.

Constitution of Board:

The Assam State Agricultural Marketing Board with its head quarter at Guwahati is a statutory and apex body established under the Assam Agricultural Produce Market Act, 1972 for exercising the powers conferred on and duties assigned under the Act and as directed by the State Govt. The Market Board was constituted vide Govt. notification No.AGA/616/75/90 dated 24/09/1976 with one non-official Chairman and 11 (eleven) members. The first meeting of the Board was held on 26-02-77.

Shri Palit Kumar Borah has been nominated as the Chairman of the Board vide Govt. notification No. AGA.337/2001/Pt/178, dated 7th March, 2017.

Regulations:

1. Regulated Market Committees:

To protect the interest of the agriculturists and traders, the Govt. of Assam constituted 24 (twenty four) nos. of Regulated Market Committees all over the State, except the areas of sixth schedule, with declaration of 20 (twenty) nos. of Principal Market Yards (PMY) and 206 (two hundred six) nos. of Sub Market Yards (SMY) so far.

2. Notified agricultural commodities:

As per the definition in the Assam Agricultural Produce Market Act, 1972, agricultural produce means and includes any produce whether processed or non-processed of agriculture, horticulture, animal husbandry, pisciculture, sericulture and forest as specified in the schedule. Following agricultural commodities have been specified by notification by the Government under Section 4(1) of the Assam Agricultural Produce Market Act, 1972.

Jute (baled and un-baled), Cotton (ginned and un-ginned), Cereals— Paddy, Rice, Muri, Chira, Khai, Wheat and wheat products, Maize, other Millets, Paddy husk, Rice brand and polished, Wheat brand and polished; Pulses—Matikalai or Matimah, Mug, Arahar, Peas, Gram, Masur; Oil seed— Seasamum or Til, Mustard, Linseed, Castor seed, Cotton seed, Coconut, Tisi; Narcotics— Tobacco; *Fruits— Mandarim, Lime, Lemon, Mussambi, Valencia, Grape fruits, other Citrus, Banana, Papaya, Guava, Jackfruits, Mango, Plum, Peaches, Pears, Apples, Pineapples, Bel, Blackberry, Rose apple, Sapeta, Melon, Tamarind; Vegetables— Potato, Sweet potato, Onion, Tomato, Leafy and fresh regetables, Yam; Animal husbandry products— Eggs, Poultry, Cattle, Sheep, Horse, Goat, Buffaloes, Milk, Butter and Cream, Ghee, Wool, Hide and Skin; Condiments and Spices— **Turmerie (whole and powdered), Ginger, Garlie, Coriander, Chillies (Dry and Green), Cardamoms and Black pepper, Betel nuts, Betel leaves, Cashew nuts, Methi, Jira, Dhania, Gur; All types of Fish (excluding canned fish); Forest products— Lac, Gum, Timber, Sugarcane, Bamboo, Cane; Sericultural products— Eri, Muga and Pat.

3. Licence:


Under section 13(2) of the Assam Agricultural Produce Market Act, 1972 (as amended) 3104 nos. of licences (Trader-1370 nos., Commission Agent-116 nos., Processor-356 nos., Storage- 3 nos., Faria- 1259 nos.) have been issued during the year 2016-2017.

4. Administrative setup:

As per Section 3(1) of the Assam Agricultural Produce Market Act, 1972 and under Rule 6(1) of Assam Agricultural Produce Market (General) Rules, 1975, the Chairman is the head of the Board and is responsible for administration of the Assam Agricultural Produce Market Act, 1972. The Chairman is also to exercise overall supervision on the Market Committees under provisions of the Act and Rules. The present Chairman, Sri Palit Kumar Borah has resumed this office on 9th March, 2017.

As per provision of the Act the Chief Executive Officer of the Board is nominated by the State Govt. who is the administrative head of the organisation and to act as the Ex-Officio Member-secretary of the Board. During the year Sri Padma Nath Das, ACS, was the Chief Executive Officer of the Board.

There are five different branches to assist the Chief Executive Officer in implementation of provisions of the Act, Rules & Bye-laws framed there under as given below.

3. Farmers' welfare schemes:

- (a) Formation of Growers' Societies: The Assam State Agricultural Marketing Board has introduced a scheme for organizing the farming community to involve them in the efficient marketing system so that they can reap out the benefit of Regulated Market Scheme. Accordingly, 778 nos. of Growers' Societies have been registered till March 31, 2017.
- **(b) Paddy procurement :** As per direction of the Government of Assam in Agriculture department, the ASAMB has been notified as a paddy procurement agency in 2012-13. Since then the Board is procuring paddy under KMS in designated paddy procurement centres. The procurement since 2012-13 is shown below.

- (c) Potato procurement: As per direction of the Government the ASAMB is procuring Potato in order to provide fair price to the Potato growers in the districts of Barpeta and Sonitpur. For the purpose the Board has received Rs. 1.00 Crore from FCS& CA department. Potato so far procured by the Board since March, 2017 in the above mentioned districts is shown below.

4. Price dissemination: The Assam State Agricultural Marketing Board is disseminating information on price and arrival of agricultural commodities from major agricultural markets (a) on day to day basis through Agmarknet portal of Govt. of India (www.agmarknet.nic.in) and the website of the Board (http://asamb.in), (b) periodical price bulletin through AIR and DDK, (c) Daily updating of price of major commodities through display boards in 13 nos. of RMC's and the Board office.

- **5. Interactions with Farmers etc.:** The Board took part in 4th Assam International Agri-Horti Show, 2017 at Guwahati to interact with the farmers and other market functionaries in connection with the implementation of the provisions of the Assam Agricultural Produce Market Act, 1972.
- **6. Agricultural Market Reforms:** The Assam Agricultural Produce Market Act, 1972 is under the process of amendment/repeal at Govt. level, as a part of Agricultural Market Reforms, in the light of the Model Act 2016 circulated by Govt. of India.
- 7. Computerization: Steps are being taken for computerization of activities of the Board and RMCs. One Programmer and one Asstt. Programmers have been hired from National Informatics Centre Services Inc. They are engaged in training to officials and development of necessary software etc. for the Board under the guidance of NIC, Assam unit. Essential ICT infrastructures are being created. Accounts of the Board has been computerized through Tally.ERP9 system with required training to Accounts personnel. 11 nos. of nodes viz. Srirampur CG, Chagolia CG, Guwahati BG Point centre, Jorhat, Tinsukia, Sonitpur, Kokrajhar and Bongaigaon DRMC, Lanka and Dhing RMC and Guwahati SDMC have been connected online through e-CMS with the Board's head quarter. The e-CMS software has been installed in these nodes for entering data online. To simplify the process of issuance/renewal of licences to the market functionaries an application software 'e-Licence' has been developed.
