NOTIFICATION

Dated Dispur 7th December '2012

No.FSB.30/10/Pt/468: Whereas, Government of Assam have decided to procure 'Paddy' under Minimum Support Price (MSP) and also under the scheme of Custom Milling of Rice (CMR) during the Kharif Marketing Season (KMS) 2012-13 through Food Corporation of India, and Assam State Agricultural Marketing Board (ASAMB) in addition to procuring 'Rice' as levy from the Licensed Rice Millers of the State through Food Corporation of India at procurement price at the rate of 50% of the quantity of rice actually milled by them from their own stocks of paddy as per the provisions of the Assam Paddy and Rice Procurement (Levy and Licensing) Permanent Order, 1995 read with the Assam Paddy and Rice Procurement (Levy and Licensing) Amendment Permanent Order, 2000 and policy/norms/ guidelines for procurement of paddy and rice formulated/to be formulated by the State Government in this regard.

And whereas, pursuant to Central Government instruction, the Government of Assam in Food, Civil Supplies and Consumer Affairs Department vide Notification no. FSB.150/11/Pt/10 dated 29/11/2012 has notified in Schedule- III, IV, V and V-A of the Assam Paddy and Rice Procurement (Levy and Licensing) Permanent Order, 1995 read with the Assam Paddy and Rice Procurement (Levy and Licensing) Amendment Permanent Order, 2000 notifying the procurement prices of paddy, uniform specification of all verities of paddy, and uniform specification for Grade- A and Common Rice for the Kharif Marketing Season (KMS) 2012-13 respectively indicating the period of procurement for FCI as w.e.f. 15.12.2012 to 30.04.2013 and for CMR as w.e.f. 15.12.2012 to 30.05.2013 showing Revenue District wise Paddy Procurement Centers(PPC) along with break-up of target of procurement of paddy proposed to be made by Food Corporation of India, and Assam State Agricultural Marketing Board (ASAMB).

Now, consequent upon receipt of approval of the Central Government in the Ministry of Consumer Affairs, Food and Public Distribution, Department of Food and Public Distribution, New Delhi vide No. 192(26)/2012-FC.A/Cs dated 29th November 2012 read with Annexure appended therewith for payment of the provisional rates of Custom Milled Rice (CMR) of Fair Average Quality (FAQ) for Central Pool to the Government of Assam and its Procurement Agencies during the Kharif Marketing Season (KMS) 2012-13 and in exercise of the powers conferred under (h) of Clause 2 read with schedule III (paragraph B) of the Assam Paddy and Rice Procurement (Levy and Licensing) Permanent Order, 1995 read with the Assam Paddy and Rice Procurement (Levy and Licensing) Amendment Permanent Order, 2000, the Governor of Assam is

pleased to fix and notify the provisional rates of Custom Milled Rice (CMR) of Fair Average Quality (FAQ) together with breakup of approved admissible incidental costs of per quinta of such rice delivered to the Central Pool, during KMS-2012-13 in respect of Government of Assam and its agencies, as required under paragraph -B in Schedule III of the aforesaid Control. Order and subject to the conditions as laid down and with immediate effect.

Other Conditions

- The payment of commission to societies will be subject to conditions laid vide Ministry's order no. 192(4)/2003-FC A/Cs (Vol II) dated 16.10.2012
- In addition to above, the Central Government will reimburse to the Government of Assam, the following elements / items

- (i) Guarantee fee, if it is actually paid by the agencies to the State Government for obtaining . credit, would be payable on actual basis , subject to a maximum of 1/8 % of MSP worked out on the estimated quantity of paddy delivered to FCI procured under Price Support Scheme (PSS) for the Central Pool. No interest on delayed payment on this account will be payable
- (ii) For transportation of paddy and rice beyond 8(eight) kilometers, the charges are payable best on rate fixed by the District Collectors of the State or FCI's rate which ever is lower.
- The Custom Milled Rice (CMR) would be delivered by the Procuring Agencies to FCI
 in new 50 Kg bags only, in its local go-downs up to the scale point and the stacking
 in the FCI go-down will be done by FCI.
- 4. The rate /cost of Custom Milled Rice (CMR) and other elements as indicated above are provisional. The State Government should send its plains for final incidentals along with accounts Audited by Auditors appointed by the Comptroller and Auditor General and documentary proof and detailed justification for each item at the earliest after the end of the season.
- 5. To ensure proper utilization of funds/subsidy being released by the Government of India, the FCI may insist on requisite certificates from the State Government and its agencies before release of incidentals on account of statutory charges i.e. Market Fee, RD Cess etc as per past practice.
- 6. These provisional rates/cost sheets are only for paddy/CMR procured by the State Agencies/FCI and not for any other party acting either on behalf of such State Agencies for the FCI. These rates would not be benchmarked to fix rate for such parties.
